Excellence, innovation, progress and prosperity are the values that motivate ROTOLITO to continuously upgrade, strengthen its processes and management systems in order to guarantee the highest ESG standards.

Abiding by all relevant laws, regulations, and other industry and compliance obligations is the foundation of ROTOLITO's commitment, and adopting a systemic approach that integrates ISO 14001, ISO 9001, FSC, PEFC, SEDEX standards, certified by independent, third-party entities, proves a commitment that goes beyond mere compliance, and is aimed at the prosperity of all stakeholder. Applying an integrated management system not only entails accounting for processes, responsibilities, impacts, but also and above all measuring, understanding and knowing ourselves on multiple dimensions: health and safety at work, corporate social responsibility, environmental sustainability, product quality and safety. Furthermore, the Code of Ethics and the Organizational and Management Model pursuant to Legislative Decree 231/01, define a set of rights and duties that must be observed by the company's directors, managers, employees, and stakeholders bound by a direct or indirect collaborative relationship, so as to operate with appropriate fairness, competence, and responsibility in order to ensure prosperity and continuity for the business and the people who contribute to it over time.

As part of its duties and commitment to the company's broad goals, management is solicited to spread awareness of its duties, role, rights and obligations to all people working under the organization's control, including through concrete example of its behavior.

Top management periodically reviews its developmental policies to ensure continuous alignment and adaptation within the organization, constantly seeking to improve its performance, encouraging the pursuit of the following macro-objectives related to the entire ROTOLITO group:

3. **Reduce the environmental impacts of the organization's activities/products/services** by meticulously monitoring and mapping material issues and their causes, then eliminating and reducing the negative externalities produced on the environment;
4. **Improve the ESG performance of our supply chain** by engaging and guiding business partners with initiatives to assess and reduce impacts;
5. **Achieve and maintain a zero injury level** by continuously assessing occupational health and safety risks and implementing effective prevention and protection measures;
6. **Promote a transparent and constructive dialogue with stakeholders** to ensure adequate communication and information on the commitment made and to be able to respond to everyone's needs and requests;

Quality and Innovation


ROTOLITO is committed to achieve ever-increasing levels of customer satisfaction through continuous improvement in the quality of products and services, and particularly to:
